The Group Adult Foster Care (GAFC) program provides assistance to elderly, low-income Massachusetts residents living in a group home. Benefits include personal care services, homemaker services, and medication management and administration.



No Cost to Members!

MassHealth funds this service at no cost to its members. Members will not have to pay their Direct Care Aide.

GROUP ADULT FOSTER CARE (GAFC)



ELIGIBILITY

- Must has MassHealth (Standard or CommonHealth) Can be a member of SCO or One Care Program, Fallon, United Health Care, SWH, TUFT, and CCA
- Age 22 or older
- Must be ABLE to live alone
- Needs daily physical assistance or supervision with at least one activity of daily living, such as bathing, dressing, toileting, transferring, walking, or eating
- Does not require full-time skilled nursing care
- Is under the care of a physician
- Must be willing to ACCEPT a Direct Care Aide

DIRECT CARE AIDE RESPONSIBILITIES

- Provide assistance necessary for the person served well-being, such as with shopping, laundry, light housekeeping, and PC services.
- Comply with the person served Plan for Care written by the Registered Nurse and Care Manager following their assessment.
- Keep records and report changes in participant's condition to the Group Adult Foster Care Team.

CENTRO SUPPORT

- Carefully access the person served needs
- Care management and Services Coordination as needed
- Periodic visits by Care Managers and Registered Nurses to monitor medical conditions, evaluate person served services, and offer support
- 24 hour coverage for emergency

- Are you 22 or older with a diagnosed medical condition?
- Do you have MassHealth Standard?
- Do you have a medical condition?
